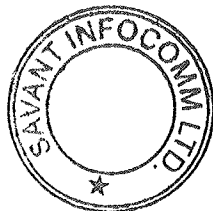

1. We have reviewed the accompanying statement of unaudited financial results of Savant Infocomm Limited ('the Company'), for the quarter ended 31st December, 2019 ('the statement'). 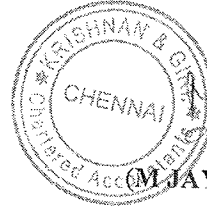
5. *Matters of Emphasis*
